Paperless eCCF™

eScreen's software and point-of-care solution is the first application to incorporate use of an eCCF™, an electronic Chain-of-Custody that addresses the problems with paper-based processes. eScreen processes approximately 2 million electronic Chain-of-Custody events every year and has a track record of successfully executing approximately 10 million electronic chain of custody events to date.

The Inbox

The MyeScreen.com inbox displays the status of a donor's drug test results to the hiring manager. Once a confirmed result is available, the donor result status is immediately updated and displayed for review. Hiring Managers can receive, view and print confirmed test results and donor status directly from the Inbox.

Donor Event Scheduling

Register a drug test at the eScreen Occupational Health Network (EOHN) clinic. Event scheduling creates an ePassport that provides all the necessary information regarding the drug test. The donor proceeds with the ePassport, to the clinic location for their drug test. This function allows employers to track missed events, time of collection, and donor status. The entire process is expedited via pre-authorization at the clinic.
